

# **Save Your Seats Promotion**

The terms and conditions stated herein apply to the *"Save Your Seats"* Promotion only. All terms and conditions stated in the Master Service Agreement (MSA) and VoIP Services Agreement that do not apply to the terms within this addendum are active for Votacall and Customer.

### 1. Promotinal Code Availability

Access to a "Save Your Seats" Promotion Code will close on November 22nd, 2019 at 11:59 PM PT.

# 2. Promotion Period

The "Save Your Seats" Promotion runs from October 15th, 2019 to December 31st, 2020 at 11:59 PM PT.

# 3. Promotion:

From 10/21/2019 to 11/22/2019 sign up for the *"Save Your Seats"* Promotion Code. Any business that enters into an agreement with Votacall for the Votacall business-class cloud phone system from 10/21/2019 to 12/31/2020, the business will get 3 months of free service. If the business does not need a new phone system during the promotion period, there is absolutely no penalty for signing up and receiving the "Save Your Seats" promo code. Votacall reserves to extend and/or alter the dates in which the promotion code is available. Votacall reserves the right to cap and close registration at any time.

# 4. Eligibility

To redeem the *"Save Your Seats"* Promotion Code and receive 3 months of free Votacall service the following criteria must be met: (i) the Business must be located in the United States; (ii) the business must have a minimum of 15 employees or phones; (iii) Customer must enter into a 36 month term for the Votacall cloud phone system; (iv) add-ons after the execution of the MSA and VoIP Service Agreement and/or after the initial implementation are eligible for the promotion; (v) there is a limit of ONE (1) redeemable promotion code per customer or organization.

### 5. Free Service Definition

### 5a. Included

Votacall defines Free Service within the "Save Your Seats" Promotion to include the following monthly recurring charges (MRC): (i) all user licensing billed monthly; (ii) all solution licensing billed monthly; (iii) standard U.S. based usage; (iv) any equipment included in the Votacall equipment rental program.

### 5b. Not Included

Items that are not appplicable to the *"Save Your Seats"* Promotion are, including but not limited to: (i) usage associated with an inbound toll free number, international calling, conference bridge calling, 911 and 411; (ii) Any applicable taxes, fees and surcharges; (iii) leased equipment (not under the Votacall Rental Program), re-used equipment and/or any equipment paid for upfront; (iv) any applicable installation charges; (v) any software, service, hardware and/or licensing not provided by Votacall (vi) any buyout fees not associated with Votacall's Cloud products and services.

### 6. Promotion Fulfillment

If customer is eligible for the *"Save Your Seats"* Promotion based on the terms above, Votacall will remove applicable charges from the qualifying Customer's bill in months 10, 20 and 30 of the 36 month term. Votacall must receive complete and executed contracts within the promotional period.

### 7. Restrictions

Additional "Save Your Seats Promotion restrictions: (i) cannot be combined with any other promotion; (ii) offer is not available to Votacall Channel, Referral or any other non-direct Partner relationship sales, valid for Direct accounts only.
